AMENDED SPECIAL USE/CONDITIONAL USE PERMIT

January 17, 2020

Joe Trolz, Gun Range
2881 N. Portage Road

At a Leoni Township Board of Trustee meeting on November 12, 2019 a motion was made by Nora Sharp-McGee and supported by Jerry Cox to approve the Gun Range at 2881 N. Portage Rd., Parcel #000-09-25-101-001-00, for a Conditional/Special Use Permit with the following conditions, in addition to all conditions, in effect of November 12, 2019, in the Township Ordinance, Sec. 42-153(c)(13) (as evidenced by the Township Zoning Administrator's checklist presented to the Township Board:

- 1.) Firearm restrictions: up to but not including .50 caliber BMG
- 2.) Handguns: all calibers
- 3.) Shotguns: all calibers
- 4.) Limit of 15 shooters on the firing line
- 5.) Days & hours of operation: 8 am to 6 pm Monday thru Friday, 8 am to 6 pm on Saturday, and 10 am to 5 pm on Sunday
- 6.) No shooting on New Year's Day, Easter, Memorial Day, Labor Day, Christmas Eve and Christmas Day
- 7.) Low light shooting allowed on the first and third Saturday of every month up to 11 pm
- 8.) Liability requirements: \$1 million listing Leoni Township as Certificate Holder and Additional Insured
- 9.) Safety compliance: most recent NRA Range rule book or most current guidelines recognized by DNR
- 10.) Miscellaneous: Under age 17 must be accompanied by parent or guardian
- 11.) Lead removal as per ordinance and EPA guidelines

Motion was carried

Therefore, this Special Use Permit is hereby issued, with effect back to November 12, 2019, to Joe Trolz for Parcel # 000-09-25-101-001-00, under the conditions listed above, the permit to run with the land and subject to all applicable law including, but not limited to, law on the cessation of use and on the right of aggrieved persons to appeal the issuance of this permit.
