The Leoni Township Board of Trustees held a Special meeting Monday, March 28, 2011 at 6:00 P.M. in the Leoni Township Meeting Hall, 913 Fifth St., Michigan Center, Michigan.

Members Present: Supervisor Todd Brittain, Clerk Michele Manke, Treasurer Brenda Vreeland and Trustees Judy Southworth, Joan Spicer, Dan Hunt and Jerry Ambs.

BRIEF PUBLIC COMMENT:

John Zang (Manager of the Treatment Plant) presented his cost analysis budget to the Board for a possible rate increase for sewer to cover operations, maintenance, wages, replacement and bond debt for Wastewater Treatment.

Motion by Vreeland supported by Hunt to approve the following increases effective April 1, 2011 to be billed after May 1, 2011:

- 1.) Treatment rate goes from &17.45 to \$21.52 per month (all sewer users)
- 2.) Non-Routine Maintenance from \$3.60 to \$5.48 per month (all users of Leoni's Maintenance)
- 3.) Repair & replacement from \$1.40 per month to \$5.00 per month (Leoni residents only)

These changes will make the Leoni Township residents bill \$32.00 per month for Sewer.

Motion by Vreeland supported by Spicer to accept the recommendation of the proposed rate increase from the Regional Sewer Authority, to pass along to client Townships knowing it will be billable April 1, 2011.
